- Total Operating Funds reported at \$2,290,629.
- NFS Investment Funds reported at \$2,413,150.
- Total Reserve Funds reported at \$2,845,118.
- Total Funds \$5,135,748.
- Income running below estimates mostly due to Grant delays.
- Overall Income is running within the estimated budget 95.5%,
- Variable income reported at \$7,700.
- Expenses reported at \$188,363.
- Current overall operational expenses are within the estimated fiscal budget for this time period.
